The sweepstakes begins at 9:00 am CST on 10/24/2018 and ends at 5:00 pm CST on 12/08/2018 ("Promotion Period").

1. **TO ENTER:** During the Promotion Period, visit one of our participating Wallace Management Co affiliate branches (see the affiliate list below), complete an official entry form, and deposit it in the sweepstakes entry box.
